

# MINUTES OF THE REGUAR MEETING OF THE BOARD OF TRUSTEES LINCOLNSHIRE-RIVERWOODS FIRE PROTECTION DISTRICT

### May 17th, 2023

## HELD AT 671 WOODLAND PARKWAY, VERNON HILLS, VERNON TOWNSHIP, LAKE COUNTY ILLNOIS

Trustee Chris Kennedy called the May 17th, 2023, meeting of the Board of Trustees of the Lincolnshire-Riverwoods Fire Protection District to order at 2:00 p.m. with the Pledge of Allegiance at the Station 53 (671 Woodlands Parkway) Training Room.

Roll call attendance was taken as follows: Trustee Chris Kennedy–present; Trustee Anthony Hanes – present; Trustee Wendy Meister-absent.

Also, in attendance were Chief Tom Krueger, Deputy Chief Mike Brown, James Howard - Governmental Accounting; IT Coordinator/Project Manager Keith Halfman, Attorney Shawn Flaherty, several LRFD members and probationary candidates (Garcia and Moskal) family members. Quorum present.

Public comment – No comments or questions were made by the present audience.

Trustee Meister arrived at 2:12 pm.

**ATTORNEY REPORT:** Attorney Shawn Flaherty advised the Board that Illinois legislators' session is over for the Spring 2023. Several bills being presented, tax credit for volunteer firefighters (state income tax credit), District property real estate appraisal revisions, bid proposal (\$20k to \$30k), Chicago FD / PD duty related illness (Covid) legislation.

#### **FIRE CHIEF'S REPORT:** Chief Tom Krueger updated the Board on:

- 1. Chief Krueger informed the Board of the current injury status of two (2) firefighters.
- 2. The new hire eligibility application process should "go-live" week of May 15<sup>th</sup>.
- **3.** The new SCBA (Scott air packs) have arrived, and in-service training will commence.
- **4.** Three (3) firefighter paramedic candidates are performing and progressing well.
